The current bylaws state that payables over \$1,000 need board approval.

There as a discussion regarding vacation rentals. There has been no response from Owner Lowry and his request for reduction because of vacation rental holds. Lurlyn reported that if vacation rental status is removed from the County, there is a waiting list to get back on. There have been no requests for payment plans.
